

Class Business



Each year CEO students create a class business in the fall semester. The profits earned by the students help fund startup costs for their individual businesses as well as other priorities established by the students.

The challenges of starting a successful class business during COVID were significant. The CEO students came up with the perfect event – a socially distanced drive-in movie experience called The Greater Decatur Movie Night. The students developed a detailed business plan that included market research, financial projections, logistics plans, marketing strategy and more. Every aspect of the Movie Night was planned and executed by the students.

The event was a success and attracted a number of community members to both nights of the event. The net profit from the event was \$3,827.88. When combined with \$272.75 from the student's badge business, a total of \$4,100.63 in funding was available. The students elected to split the revenue as shown in the table to the right.

Funds for Individual Businesses	35%	\$1,435
Donate to local charity (NCC)	30%	\$1,230
Scholarship for a current student	25%	\$1,025
Invest in CEO	10%	\$410

Scholarship criteria were established by the students and approved by the board. An essay was required. A group of board members reviewed the applications and selected Sidney Manasco to receive the scholarship funds.

Over the course of the year, CEO students prepared multiple business plans and presented them to bankers and investors. The feedback from these experienced professionals helped the students realize the cost of starting a business.

CEO Trade Show

Students held their Trade Show at Royalty Funnel Cakes. This annual event is the culmination of the CEO year and spotlights the businesses created by each student in the class. All students sold products and services at the event.

CEO students visited dozens of area businesses, where they toured facilities and interviewed owners, managers, and employees. Business visits are an eye-opening experience, as students are able to explore and learn about local companies they have passed by all their lives. Business visits build a deep understanding and strong connection between our present and future business leaders.


